- A close associate of a politically exposed person is any natural person who is known to have joint actual ownership of a legal entity or legal arrangement or any other close business relationship with a politically exposed person or who is the sole beneficial owner of a legal entity or legal arrangement for which known to have been established for the welfare of politically exposed persons.
